

## **RESULTS OF 2023 ANNUAL GENERAL MEETING**

23 November 2023

In accordance with ASX Listing Rule 3.13.2 and section 251AA(2) of the Corporations Act 2001 (Cth), the following information is provided to ASX Limited in relation to resolutions put to members of Australian Silica Quartz Group Limited at its 2023 Annual General Meeting held today on 23 November 2023.

Resolutions 1 to 8 which were Ordinary Resolutions were passed on a poll with a simple majority.

Resolution 9 which related to an amendment to the Constitution to Renew Proportional Takeover Bid Approval Provisions which was a Special Resolution requiring 75% of the votes cast on the day was narrowly defeated with 72.7% of those voting in favour of the resolution on a poll. As a consequence of this the Proportional Takeover Bid Approval Provisions in the Constitution will lapse with immediate effect.

A detailed breakdown of the 2023 AGM results are listed in the attached table.
