He is currently managing director of Brolga Consulting Pty Ltd, and non-executive director of Exergen Pty Ltd and LVNG Pty Ltd.

Bauxite Resources Chairman, Mr Barry Carbon, believes the appointment of Mr Sibly to the Bauxite Resources Limited will prove a key milestone in the development of the BRL assets and the Company's broader refinery plans.

"I am extremely pleased that John has agreed to join the Board," he said.
